The Directorate General of Intellectual Property under the Ministry of Law and Human Rights of the Republic of Indonesia has the task of carrying out the formulation, implementation of policies in the field of Intellectual Property and functions as an organization that provides guidance, legal protection, law enforcement and dispute resolution, monitoring and evaluation, especially in the field of Intellectual Property in Indonesia.

In terms of law enforcement and dispute resolution, the Directorate General of Intellectual Property has a Directorate of Investigation and Dispute Resolution.

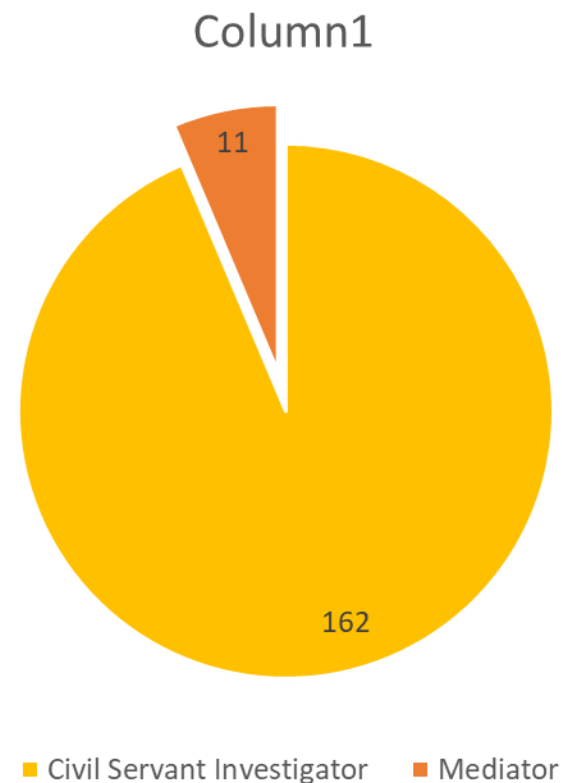


DIRECTORATE OF INVESTIGATION AND SETTLEMENT OF INTELLECTUAL PROPERTY DISPUTES

In carrying out its duties and functions, this Directorate plays a role in technical guidance for prevention, investigation, settlement of disputes over suspected criminal acts in the field of intellectual property including trademarks, patents, copyrights, industrial designs, layout of integrated circuits, trade secrets and plant varieties.

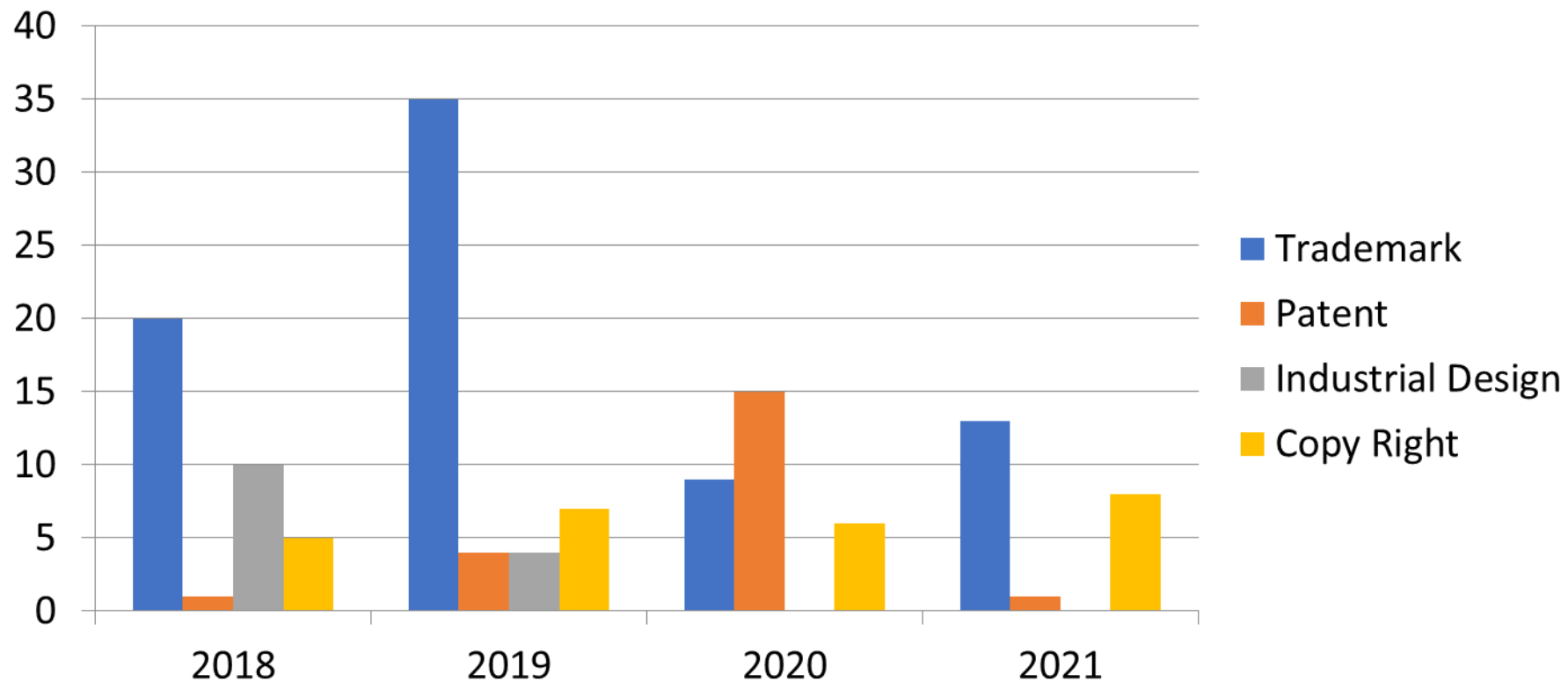

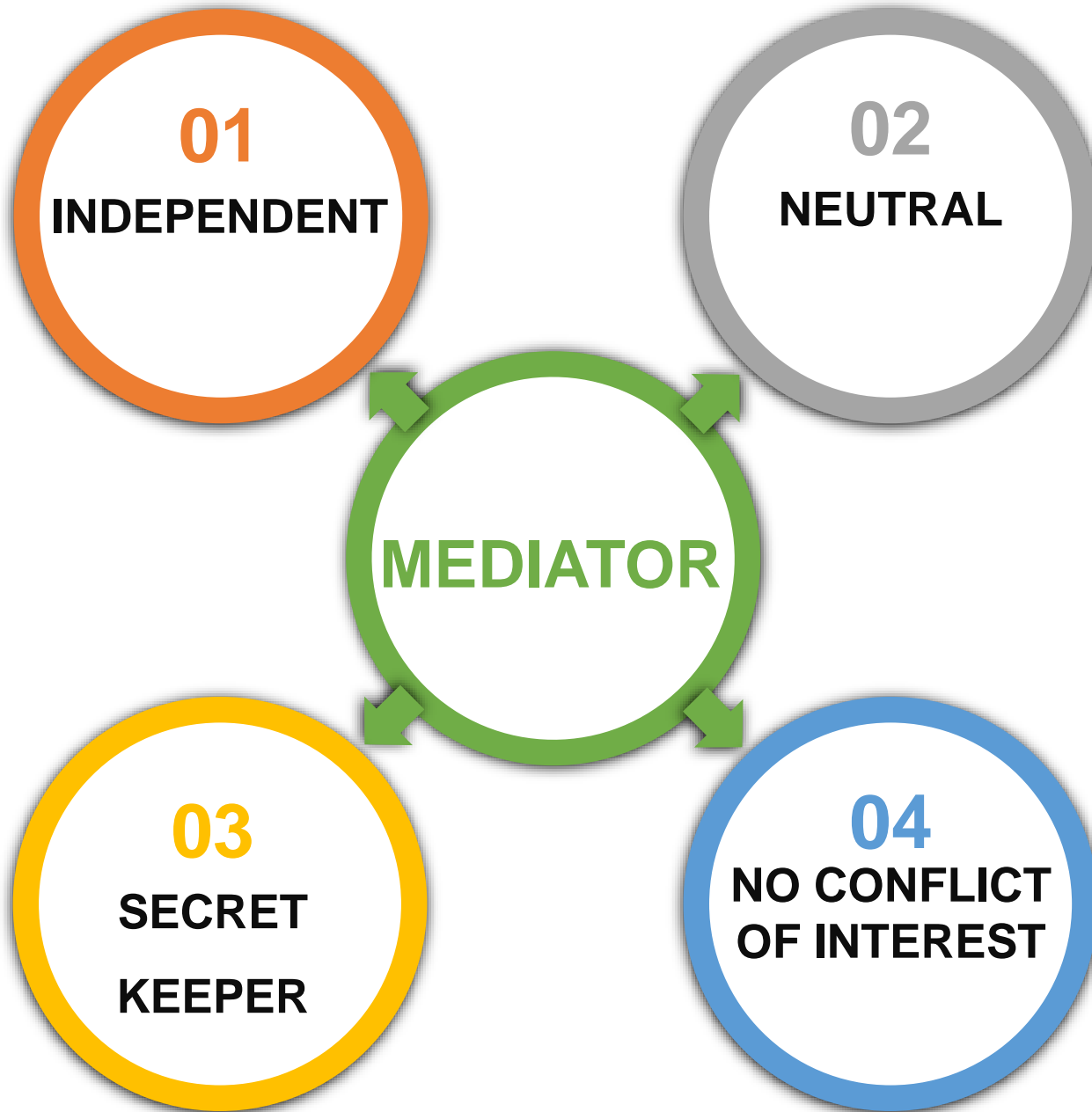

INTELLECTUAL PROPERTY MEDIATION MECHANISM IN INDONESIA

1. The disputing parties submit an application for mediation to the Directorate General of Intellectual Property
2. Appointment of Mediators
3. Inviting the parties separately (early stage of mediation to obtain initial information)
4. The implementation of the Mediation process brings together the two parties
5. Created the results of the Mediation Minutes



INTELLECTUAL PROPERTY DISPUTE RESOLUTION PROBLEMS IN INDONESIA

1. There is still a lack of public understanding of the benefits of intellectual property mediation that is fast, cheap and provides definite legal certainty
2. There is still a lack of socialization and education on alternative dispute resolution in the field of Intellectual Property
3. There is still a lack of mediator officers who handle mediation cases because the Directorate General of Intellectual Property is more concerned with the investigation process



EFFORTS OF THE DIRECTORATE GENERAL OF INTELLECTUAL PROPERTY

1. Conducting socialization and education on the benefits of intellectual property mediation in Indonesia
2. Conducting training and guidance for new Intellectual Property mediators in 2021 and has just finished training in September about 30 participants
