BACKGROUND OF ENFORCEMENT DIVISION, MDTCA

Established on 17 April 1972 under the Ministry of Trade and Industry (MTI) – to curb inflation. On 27 October 1990, the Ministry was restructured to form two ministries namely the Ministry of International Trade and Industry (MITI) and the Ministry of Domestic Trade and Consumer Affairs (MDTCA).

BACKGROUND OF PROTECTION AND LAWS OF IP IN MALAYSIA

 Intellectual Property Corporation of Malaysia (MyIPO) is the custodian of IP law in Malaysia, but have no enforcement mechanism. Malaysia was placed in the USTR Priority Watch List in 2000 and 2001. In 2002, significant improvement was made on IPR protection. Malaysia was then removed from the Priority Watch List.

• In 2012 Malaysia had been removed from the Watch List.

- Enforcement of criminal IP is under the jurisdiction of MDTCC.
- Several steps taken by the government to combat piracy and counterfeit goods:
 - Special Task Force Committee (co-operation with LEAs)
 - Special Unit to tackle online piracy and counterfeit issues
 - -Co-operation with brand owners (intelligence,
 - operations, training)
 - Action also taken under AMLATFPUAA 2001

Arrest case, charge the accused in less than one month
