

TRAINING OF LOCAL IP VALUERS

An IP Valuation Training Module was developed by MyIPO and launched on 7th March 2013. The availability of local IP valuers will make IP valuation more accessible and affordable especially for SMEs.

- Comprehensive curriculum
- Must pass final examination
- Hands on valuation experience

IP Valuer Training Module



- 2 batches of training
- A total of 53 candidates
- 23 passed the examination




INTELECTUAL PROPERTY VALUATION MODEL (IPVM)

- Launched in 2013 during the inaugural Global Intellectual Property Valuation Conference (GIPVC) in Kuala Lumpur.
- "Malaysian" in nature
- Suitable for lenders & financiers
- Support the acceptance of IP rights as part of financing

Salient Features of the IPVM

- 3 key considerations:
 - sufficiently accurate for collateral purposes
 - easily implementable by lenders
 - cost-effective in relation to the loan amount





VALUATION CONDUCTING IP VALUATIONS

Outcome


- More than 20 valuations on SME IP rights
- Conducted by foreign IP valuers for financing purposes
- Used as hands-on training for local IP valuers
- Based on the IP Valuation Model
- Conduct discussions and competency building with financial sectors on the IP valuation report and IPVM

CAPACITY & CAPABILITY DEVELOPMENT

Critical to the success of a vibrant IP ecosystem are the participation and involvement of relevant stakeholders and the industry.

Organised and initiated various programmes, awareness sessions, dialogues, seminars and conferences to engage various relevant stakeholders as well as to improve and develop capabilities in the areas of IP valuation, IP financing and IP commercialisation and monetisation.









IP FINANCING SCHEME (IPFS) BY MALAYSIA DEBT VENTURES (MDV) (2013 – 2016)

- The RM200 mil fund was launched in Dec 2013
- Leverages on Malaysia Debt Ventures Berhad (MDV)
- Financing of up to RM10 million or 80% of valued IP, whichever is lower
- 5 years financing tenure (inclusive of a grace period of up to 12 months)
- Annual interest rebate of 2% p.a.
- 50% guarantee, with discounted guarantee fee of 0.5% per annum
- Applicable for all MDV financing products
- Basic Requirements:
 - Registered & Valued IP
 - Meets MDV's product criteria
