#### Welcome to Caribbean TMclass

Caribbean TMclass is an online multi-lingual consultation tool offering free-of-charge access to the lists of terms accepted as suitable to identify goods and services for the purposes of the registration of marks by participating Caribbean IP Offices. Caribbean TMclass helps you search for, and verify, the correct classification of those terms for goods or services in accordance with the criteria established by the International Classification Agreement (Nice Agreement). You can also verify whether a particular term is accepted by any of the participating Offices highlighted below and get translations of those terms into the working language of that Office. Caribbean TMclass has been developed by the Intellectual Property Offices of CARIFORUM States and the CARIFORUM Directorate, under the CARIFORUM-EU Intellectual Property and Innovation Project (CarIPI), funded by the 11th EDF and implemented by the European Union Intellectual Property Office (EUIPO). Caribbean TMclass is a regional interface of TMClass for the IP Offices belonging to the CARIFORUM group of states.

- Allows applicants to delimit the specification of goods and services accurately prior to filing a mark.
- Saves time for IPOs as it will speed up the examination process when applicants use the tool prior to filing and for IPOs it's a quick and easy resource to check for acceptable specifications.

- Gives the applicant certainty in relation to which goods and services each participating office will accept.
- Free of charge and available 24/7/365.
- Contains a translation tool.





## Terms Proposed by the St. Lucian IPO

- Bouillon/bouyon
- Seamoss/sea moss (a milky drink made from sea weed)
- Accras (fish cakes/salt fish fritters)
- Bakes/floats (a bread-like sweetish fried dough)
- Ice lollies (creamy icicle sold in a plastic bag tied with a knot)
- Herbal rubs (medicine)



### Terms Proposed by the St. Lucian IPO

- Bull/comfort (confectionery)
- Peh me (a pie made primarily from corn meal wrapped in a banana leaf)
- Tablet/sugar cake (a boiled/baked confectionery made from coconut)
- Tamarind balls (confectionery made from tamarind)
- Coconut balls (confectionery made from coconut)
- Guava cheese (confectionery made from guava)

- Golden apple in sauce (golden apple (fruit) sliced in a seasoned water

### Terms Proposed by the St. Lucian IPO

- Mango in sauce (mangoes sliced in a seasoned water)
- Callalloo (chopped up or shredded spinach, Chinese cabbage or callalloo leaves eaten as a stew or broth)
- Souse (stewed pig's feet/trotters)
- Boudain/boudeh (black pudding)



- Cassava bread (bread made from cassava sometimes incorporating raisins, cherries, cinnamon, salt fish or herring etc)
- Lambi/conch (seafood)

## Way Forward

- All CARIFORUM Countries to propose terms for inclusion in Caribbean TMclass
- Once list is compiled, it will be classified according to the Nice Classification in conjunction with the EUIPO.
- After Classification, the terms and its classification / delimitation will be recirculated to the Heads of the IPOs for validation

### Way Forward

- The terms will be added to the Caribbean TMClass.
- Applicants and examiners may consult the Caribbean TMClass when applications are submitted with local terms and verify whether the terms are classified correctly.
