(1) UPOV MEMBERSHIP PROCESS

- Policy decision to draft legislation in accordance with the 1991 Act of the UPOV Convention and on becoming a UPOV member
- Contact the Office of UPOV for assistance provision of the Drafting Guidance Document INF/6 and consultations
- Finalize the Draft Law for its examination by the Council of UPOV
- Ask advice of the Council of UPOV
- If advice positive and Law in force deposit instrument of accession to become a UPOV member – entry into force one month after deposit
- A matter for each State to decide the level of contribution which it wishes to Contribute: First payment - month of January following accession

(1) UPOV membership process: benefits

- Internationally accepted and harmonized sui generis
 system
- **Protection for Breeders** in other UPOV members
- Benefit from **national treatment** and **priority**
- **Co-operation** in examination, protection and enforcement
- Legal and Technical guidance
- Awareness / Influence of future developments



- If advice positive: deposit instrument of accession







Cont. (2) Steps of the UPOV membership procedure: draft law approved/law adopted

(a) Ask Council of UPOV to advise on conformity of its draft law/law (Article 34(3) of the Convention)

(b) If the advice of the Council is positive: deposit the instrument of accession

(c) Becomes a UPOV member one month after depositing the instrument of accession



Cont. (2) Steps of the UPOV membership procedure

 If the advice of the Council is positive on: adopted law/draft law adopted with no changes deposit the instrument of accession

Requirements for the deposit:

- Copy of the Law in force
- Declaration of units of contributions
- Declaration of plant genera and species covered (all or list)

Becomes UPOV member one month after depositing the instrument of accession



(3) Financial matters

- First payment of annual contribution- month of January following accession
- The value of one contribution unit = 53,641 Swiss Francs
- A matter for each State to decide the level of contribution which it wishes to contribute https://www.upov.int/edocs/pubdocs/en/upov_pub_423.pdf
- One-fifth (0.2) is the minimum level of annual contribution: 10,728
 Swiss Francs
- Payment to the Working Capital Fund of UPOV (one-time payment)



Cont. (3) Financial matters: examples of membership in 2021

Example 1: Future member A decides to pay one unit of contribution (1.0)

• to pay in January 2022

Annual contribution (53,641 Swiss Francs) + Working Capital Fund (8,333 Swiss Francs) total: 61,974 Swiss Francs

• to pay in January each year after 2022: Annual contribution: 53,641 Swiss Francs

Example 2: Future member B decides to pay one-fifth of a contribution unit (0.2)

- to pay in January 2022
 Annual contribution (10,728 Swiss Francs) + Working Capital Fund (1,667 Swiss Francs) total: 12,395 Swiss Francs
- to pay in January each year after 2022: Annual contribution: 10,728 Swiss Francs

Feedback received from Ghana the most recent UPOV member

Lessons Learnt in the procedure of development of PVP legislation and becoming a UPOV member:

- Importance of national dialogue
- Importance of national strategy
- Need for National Champions
- Availability of resources for capacity building and sensitization activities
- Collaboration and sharing of experiences
