# THE EUROPEAN TRADE MARK AND DESIGN SYSTEMS

#### **HOW IT ALL STARTED**



- 1950. Schuman Declaration the birth of the European Union
- 1964. First Draft Convention on European Trademark Law
- 1988. First council directive to approximate EU trade mark law
- 1993. Council Regulation no. 40/94 of the Community trade mark
- 1994. OHIM now called EUIPO, opened its doors



#### THE EU TRADE MARK & DESIGN SYSTEMS



- 2 main ways to register a Trade Marks and Designs in the EU:
  - national trade marks / designs, OR
  - ➤ EU Trade Marks (EUTM) / Registered Community Designs (RCD)
- National and EU rights and IP Offices coexist and are complementary to each other (the same TM/DS can be registered at EU and/or national level)
- The EUTM/RCD system consists of 1 single registration procedure that grants the owner an exclusive right in all (27) EU countries
  - Without these systems, TM/DS would have to be registered in every country separately, paying 27 different fees, dealing with 23 different languages, filing dates and practices

### **HOW IS THE SYSTEM IMPLEMENTED - LAW AND PRACTICE**



#### HARMONISATION OF LAWS

- Commission Regulations
  - binding legislative act issued by the commission direct application in all EU countries
- Directives
  - a legislative act that sets out a goal that all EU countries must achieve

#### HARMONISATION OF PRACTICE

 Through closer cooperation between the EU Member states IP Offices and the EUIPO → Convergence Programme



# **EUROPEAN UNION INTELLECTUAL PROPERTY NETWORK (EUIPN)**

EUIPO and its EU partners (Member States IP Offices) have developed the European Union Intellectual Property Network (formerly known as European Trade Mark and Design Network)

The EUIPO provides users with databases and free tools such as:

TMview TMclass DesignView	EDB   Similarity
DeSearch plus DeSearch Case Law	Orphan Works Database



### **EUIPO TODAY**

 Managing EU trade marks and Registered Community Designs



- Around 160 000 EU trade marks and 100 000 community designs registrations annually
- Observatory on infringement of IPR
- International cooperation





#### DO THE EU SYSTEMS DELIVER THE EXPECTED BENEFITS?

The TM and Design Systems are assessed regularly in relation to efficiency, effectiveness, relevance, coherence and EU added value:



# **ASEAN Trade Mark System Registration Feasibility Study**



- An ASEAN Trademark system would build upon earlier works related to harmonization in the region and support the AEC goal of deeper economic integration.
- ASEAN SMEs account for 50% of ASEAN combined GDP and 30% of ASEAN national exports (of these exports up to 60% of them are involved in IP intensive industries)
- A single trademark application that could reach all of ASEAN would help to reduce barriers to entry for SMEs and would reduce the time (and costs) involved for them protect and maintain their trademarks

# **ASEAN Trade Mark System Registration Feasibility Study**



- ARISE+IPR project just launched a feasibility study on the establishment of ASEAN Trade Mark registration system
- Model suited towards each ASEAN Member State
- Expected benefits and cost savings to the end user as well as the ASEAN IP Offices
